BOARD OF TRUSTEES "INSTANT REPLAY" August 20, 2014

The Board of Trustees met for their regularly scheduled meeting on August 20, 2014, in the boardroom at the Coastline Regional Occupational Program/Paul E. Snyder Administrative Center.

Merry Kim, Education and Partnership Development Specialist, presented the final version of the Labor Market Study 2013-14. She also reported on Coastline ROP's C-STEM (Computing, Science, Technology, Engineering and Math) Pilot Project which encompassed the participation of academic and career technical education faculty from six unified school districts and one community college. The goal of the project was to introduce the UC Davis C-STEM Program which integrates Algebra, Computing, Robotics, Science and Digital Media Arts. The Pilot Project teachers received C-STEM training, mini robots called Linkbots, software, books, and instructional materials. On Saturday, May 31, 2014, Coastline ROP organized the C-STEM Competition Day at UC Irvine's School of Information and Computer Sciences. Seventy-three high school and middle school students participated in the RoboPlay Competition and fifty students participated in the Video Competition. Winning student teams were Northwood High, Costa Mesa Middle, Corona del Mar High, TeWinkle Middle, and Corona del Mar Middle Schools. The project was highly successful and was made possible by support from Coastline ROP, partner districts, Coast Community College District, Digital Media/ICT Deputy Sector Navigator, UC Irvine, Orange County Department of Education, nonprofit organizations, and industry volunteers.
